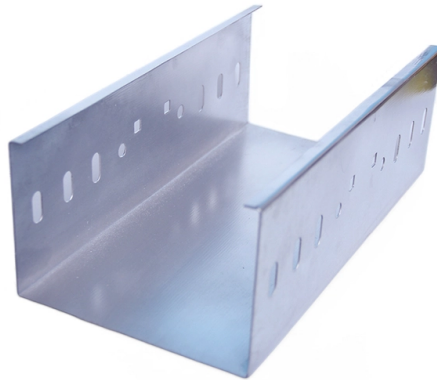


Anti-dumping policy for optical fiber cables



Overview

The European Commission has doubled its anti-dumping duties on optical fibre cables from China, following an investigation which found that Chinese exporters of optical fibre cables were attempting to impede the effects of the original measures. China's Ministry of Commerce announced on the 3rd that it would impose anti-dumping duties of up to 78.2% on some US products starting on the 4th. The companies involved include Corning, Draka Communications, and OFS-Fit. On March 4, 2025, in response to an application from Yangtze Optical Fibre and Cable Joint.
