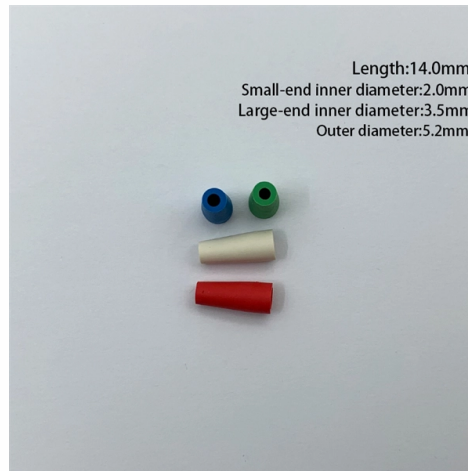


Fiber Optic Cable Industry Consolidation
