

## Optical modules affected by sanctions



### Overview

At present, the import of optical modules into the United States requires a 10% basic tariff, but according to Executive Order No. 14257, two exemptions have been obtained: one is the exemption from the 245% ad valorem tariff on Chinese goods, and the other is that tariffs from.
